



## BILLING AND REIMBURSEMENT ACKNOWLEDGMENT

There is no need to print out this form. You will be asked to electronically sign a copy during the initial consultation visit.

I acknowledge that I understand and agree that:

- Regardless of my insurance status, I am responsible for all charges incurred for professional services rendered at the time of treatment. We accept cash, check, debit cards, credit card (Visa/Mastercard).
- There will be a \$25 fee charged for checks with insufficient funds.
- A \$100 fee will be charged to my credit card if I miss an appointment or fail to notify the office 24hours prior to the appointment time.
- If I arrive late for an appointment, I will be seen only for the remainder of the time originally allotted for that visit and I am still responsible for the full cost of the visit.
- The payment fee schedule is as follows for in-office visits:
  - Initial in-office comprehensive consultation and evaluation \$300
  - Virtual televisit initial consultation \$200
  - Follow up evaluation with treatment ranges from \$150 to \$450, except for Platelet Rich Plasma (PRP), which is \$1000
- Acuprolo Institute does NOT directly bill insurance carriers, including Medicare. Upon my request, I will receive a superbill for the visit. It will be my sole responsibility to attempt to obtain reimbursement for services rendered. Furthermore, I agree NOT to attempt to get reimbursement from Medicare for the services rendered at Acuprolo Institute.
- Insurance reimbursement for injection therapies varies, and that some injection therapies (Prolotherapy, Platelet Rich Plasma (PRP), Perinueral Injection Therapy (PIT), may be considered investigational or experimental by some carriers and will not be paid for by the insurance companies. I further acknowledge that Medicare does not cover these injection therapies.
- Insurance reimbursement for the following treatments varies and that some carriers will not pay for these treatments: Traditional Chinese Medicine modalities (acupressure, acupuncture, electroacupuncture, moxibustion, and cupping), Osteopathic Manual Manipulation (OMM), Extracorporeal Shockwave Therapy (ESWT), Extracorporeal Pressure Activation Therapy (EPAT) /Acoustic Wave Therapy (AWT), and Extracorporeal Magnetotransduction Therapy (EMTT). I further acknowledge that Medicare does not cover these treatments.

- Acuprolo Institute is not responsible for any costs associated with treatment complications, such as, but not exclusive to hospitalizations, emergency room visits, costs incurred from other providers, laboratory and diagnostic imaging fees.
- I am aware the physicians in this office are not partners. They are independent practitioners who share office space, equipment and some staff in their separate practices. They are not responsible for each other's practice or patients, but may at times, cover for each other. Payments will be made to the primary doctor who provided care for that visit.
